**Subject: Urgent Concerns Direction Headed by the Federal Republic of Somalia Executive Branch**

Dear Your Excellencies

With proper support, including infrastructure development, access to markets, technology transfer, and training programs, these sectors could not only provide employment but also contribute to food security and poverty alleviation.

It is imperative that the federal republic of Somalia government takes urgent action to revitalize these sectors. This includes developing a comprehensive vision and strategy that prioritizes the needs of local communities, fostering sustainable practices, and ensuring transparent and accountable management of resources.

International donors must demand greater accountability and transparency in the use of funds allocated to these sectors. Investments should be directed towards initiatives that directly benefit Somali communities and promote long-term economic growth and resilience.


